Collectively, our old homes give residents a sense of the neighborhood's place in San Rafael's history, engendering a feeling of stability and ageless community. However, San Rafael's current historic preservation ordinance does little to really protect most of our old houses.

We'd like to plan for realistic preservation goals that benefit but do not burden the homeowner. Of course, any preservation effort would apply only to facades, not to interior renovation, and would not be overly restrictive. We all have to live in the modern world!

We'd plan to broaden Gerstle Park's listings in the city's 1986 Historical/Architectural Survey, then research ways to work with the city to achieve realistic, effective protection for our old homes. This all will take careful planning, legwork, teamwork, self-education about old-house styles, and a willingness to have fun.

THE FATE OF SHORT SCHOOL'S SITE: UPDATE

Residents and the GPNA Board have been heavily involved in the proposed plans for the 1.26 acre site located in the heart of Gerstle Park. Many thanks to everyone who has voiced concern over potential development plans (site rezoning and development of 20-40 units) as proposed by City General Plan Steering Committee members.

Gerstle Park currently has a very diverse mix of housing and is already an extremely dense neighborhood, with a density almost five times higher than that of any other census tract in San Rafael. For those of us already familiar with the effects of overcrowding, the existing density is painfully apparent. Any proposal to add more density will only add additional strain on resources while compromising the safety and quality of life in our area.

We were very grateful to Mayor Boro and Bob Brown for the productive meeting we had with them Dec. 18, which allowed us a chance to demonstrate the neighborhood's strong opposition to proposed density increases. We thank the many, many residents who came. Although the Mayor announced that the Short School site will not be zoned for more than a few units, the battle is not over — final recommendations for proposed development within Gerstle Park have not been made. Additionally, the halt on San Rafael's involvement in development of St. Vincent's/Silvera's land means that the previously planned density for that area must now be planned for elsewhere within San Rafael.

GPNA is circulating a petition opposing Short School property rezoning and development. Please contact Krystyna Barron (459-4006) or Jennifer Stroman (460-0912) if you'd like to sign. TOT LOT UPDATE

On February 20th the Park and Recreation Commission approved the renovation plans for the preschool playground area. The proposed plan calls for the preschool playground to be relocated to the lower portion of the park, adjacent to the large kid swings. The existing picnic tables near the children's play area will be removed. A few of these tables will be placed in the current preschool playground, and the remaining tables will be placed in the redwood grove by the tennis courts.

When the work is complete, Gerstle Park's new Tot Lot will be compliant with state safety and ADA laws. It will be closer to the older kids' playground, offering easier access for those parents who are supervising multiple children of different ages. The fence around the open part of the park will be extended to keep children from the street.

A new bathroom will be installed in the lower play area, accessible to the disabled. The current upper bathrooms will be renovated and made more functional. The plans now go out to bid, and the City hopes to start the project sometime this year. Updated plans are in the Gerstle Park kiosk.

In light of some controversy, we want to clarify GPNA's role in the Tot Lot. At the City's request last year, we located two parent volunteers to help with the planning. The GPNA Board reviewed the initial plans in October and had no negative comment. These plans were presented at GPNA's annual fall membership meeting, and no member raised any concerns. The GPNA Winter 2002 newsletter invited Tot Lot comment and questions; we have no record of any response. The City sent notifications to immediate park neighbors about the project and about Park Commission hearings in December and February. The first hearing, with three park neighbors attending, revealed objections to a new ADA-accessible bathroom located too near San Rafael Avenue and to picnic table location. City staff changed the bathroom location and proceeded with the planning process.

When the GPNA president learned of detailed objections to the plan in early January, he immediately referred the person objecting to Carlene McCart of the Park and Rec Dept., who responded to the concerns by detailing the rationale and State safety and disability access guidelines governing Tot Lot decisions. The GPNA president forwarded the objections to GPNA Board members.

At the February 20 Park Commission hearing, two immediate park neighbors were in attendance, one of whom

expressed no reservation about the plans. The other submitted a petition against park changes signed by 62 people. Without mentioning the new bathroom, the petition's primary objections were to swapping locations of tot lot equipment with picnic tables and expressing the concern that park changes would cause such increased use of the park that increased park maintenance and security would be needed. GPNA knew of these objections but not of any widespread opposition nor did it receive the petition until weeks after the Commission meeting. In spite of the petition, the Park and Recreation Commission voted to approve the Tot Lot design.

At this writing, there has been an IJ article, and the issue is being raised with the City Council and the GPNA. If you have further concerns about this issue, please contact Carlene McCart at 485-3333.

If these park changes do come about, and if neighbors experience specific, concrete problems that arise from the changes, GPNA will be happy to work with the City to address them. We ask you to contact us through our web site, www.gerstlepark.com, or call Hugo at 456-0221. In the meantime, park disturbances should always be reported immediately to the police.

SAN RAFAEL GENERAL PLAN

San Rafael General Plan 2020 is still being worked on by the City's Steering Committee and is expected to be ready for the first public hearings later this year. The plan establishes policies for the future of our City. Your GPNA Board has contributed many pages of suggestions and input to the Steering Committee. We also attend the monthly meetings. Density, safety, housing and street maintenance are just a few of the many subjects covered. All of you should be aware of this plan and are encouraged to get involved. PREPARING FOR A DISASTER:

STEPS YOU CAN TAKE TO INCREASE YOUR CHANCE OF SURVIVAL

Disaster preparedness is all about planning and taking action. How well you plan will dictate the actions you take, which in turn will dictate your chances of survival. Sound serious? It is.

We live in a risky area and we are facing risky times. Whether it is natural (earthquake, flooding, tornado, etc.) or man-made (terrorism, hazardous material, fire, etc.) living in the San Francisco Bay Area places us all at risk.

Only YOU can plan effective preparedness for your family, and NOW is the time.

Immediately after an serious emergency, essential services such as paramedics, fire, police, public works, water, sewage and power may not be available to you for at least 72 hours. Know what to do! Here are a few tips, which we'll continue in our next issue:

- **Develop a household disaster plan, with 72 hour food, water, & medication supplies.**
- **Check into your employer's and your children's school emergency plans.**
- **Talk with your family about how to respond to emergencies, and what you would do in an evacuation.**
- **Have a family contact plan and outside meeting places identified.**
- **Arrange for family members to be able to contact someone outside the area to coordinate messages.**
- **Draw a floor plan of your home, with two escape routes.**

An excellent first step in preparing for a disaster would be to enroll in the San Rafael Fire Departments Disaster Area Response Team (DART) training program. The class is offered from 7:00 PM till 10:00 PM, once a week for six weeks and is taught by professional firefighters. The course covers all the necessary basic skills you will need to survive in a disaster. There is a \$40 materials fee, but GPNA will reimburse half of that fee to the first 20 Gerstle Park people who complete the training!

The fundamental principle of the DART program is that in a disaster, it will be neighbor helping neighbor. The more neighbors trained, the safer the neighborhood.
