Steve Patterson

Longtime Gerstle Park Neighborhood resident Steve Patterson passed away on February 20, 2012 of ALS. Steve moved to our neighborhood about 1975 and immediately joined the GPNA. He soon acquainted himself with local issues and became the GPNA President.

Steve was a guardian of this neighborhood and an untiring advocate of its interests. He was sensitive to anything that might adversely impact the quality of life and the historic integrity of our neighborhood. He was also an activist in local and national politics, giving generously of his time and his beautiful Arts and Crafts home to the candidates he supported.

Eventually, Steve, along with some other Gerstle Park residents, formed the Federation of San Rafael Neighborhoods. He brought all of San Rafael's neighborhoods together in an extraordinary group of people from around the city. Their goal was to advocate for themselves and for each other on vital issues and to form a constructive dialogue with city officials. Steve was the founding Chairman of the Federation and held that position until his death. His goal was to help others advocate for their own interests; his achievement was giving residents a beautiful sense of community.

Steve's devotion to Gerstle Park and to the city of San Rafael will be missed. He leaves many grieving friends.

Ritter House Update

A Gerstle Park resident filed an appeal of the Planning Commission's approval for Ritter Center to add a medical trailer and place dumpsters at the front of their site which includes a historic building. Ritter Center is a non-profit organization that provides important services to the needy and homeless, located on Ritter Street in downtown San Rafael.

The appeal was filed for three reasons:

- The trailer and dumpsters would be a visual blight from Third Street, a gateway street to San Rafael. The proposed trailer, adjacent to a historic building, is an inappropriate structure for downtown and sets an unacceptable precedent.
- 2. The county has built a \$70 million, state-of-the-art medical center about a mile away. Potentially Ritter Street clients could be served there. Since the Ritter expansion is funded by a federal grant, this may be a duplication of services and a waste of taxpayer money.
- Downtown businesses, neighbors, visitors and prospective businesses suffer the effects of Ritter's already over-extended site.

A public hearing on the appeal will be held April 2, 2012 in the City Council chambers, City Hall, at 8 p.m. All of you are encouraged to attend.

The GPNA unanimously passed the following resolution at the last Board meeting.

The GPNA Board supports the Appeal to the City Council of the San Rafael Planning Commission's February 14th decision (Ritter Center, UP11-070/ED11-089) because the decision was based on need rather than appropriate City planning criteria. Ritter is already in violation of their current use permit by treating more people than their permit allows on a daily basis, the proposed modular trailer is an architectural blight and the proposal needs a sunset clause.

Professional Baseball Comes to Albert Park... Maybe

On February 28, 2012, Judge M. Lynn Duryee ruled in favor of Centerfield Partners, LLC; thus, clearing the way to bring professional minor league baseball to Albert Field. The ruling against the Albert Park Neighborhood Alliance (APNA), which sought to have the court mandate that an Initial Study of Environmental Impact be conducted by an independent third party prior to allowing any use of the park for professional entertainment, also states that the 1 year Use Agreement between Centerfield Partners and the City does not violate the 1 week commercial use restriction contained in Jacob Albert's 1937 Deed of the parkland to the City.

APNA believes that there is a very real possibility that allowing professional baseball to be played at Albert Field, under the terms of the present Use Agreement, will provide a precedent for future commercialization of the park. APNA, whose members comprise various individuals of the Gerstle Park, Southern Heights, Picnic Hill, Bret Harte and Downtown neighborhoods is presently assessing its options, which include the possibility of appealing the Judge's decision.

Dog Leash Ordinance

For the safety of others, it is required by Municipal Code to keep your dog leashed at all times in San Rafael, otherwise you may be cited for a misdemeanor and a penalty up to \$500. We must avoid tragic dog attacks such as transpired last month where it was reported a Labrador fatally injured a Pomeranian in our own Gerstle Park. San Rafael has a designated off-leash dog park near the Civic Center.
