Revisiting the Golden Gate Ferry Shuttle Program

In our Summer 2001 issue, we included a neighborhood survey regarding possible Gerstle Park routes for a Golden Gate Transit bus and ferry shuttle. There was some neighborhood interest in a shuttle serving our area, but the proposed route met with a less than enthusiastic response. Therefore, Golden Gate Transit is offering up the following two possible alternative routes, plus the originally proposed route:



OPTION A

Eastbound: From Fourth Street - turn right onto B Street, left ontoWoodland Avenue, to Bellam, then right on Andersen.

Westbound: From Woodland Avenue - right onto B Street, left onto First, right onto C Street, left onto Fourth

OPTION B

Eastbound: From Fourth Street - turn right onto A Street to Andersen Westbound: Andersen to A Street to Fourth Street

OPTION C (Original Proposal)

Eastbound: From Fourth Street - turn right on D Street, left ontoTaylor Street, continuing onto Woodland Ave to Bellam,

then right on Andersen.

Westbound: From Woodland Avenue - right onto B Street, left onto First, right onto C Street, left onto Fourth.

We have developed survey questions on page 3 in the hopes that each of you will take the time to respond, even if you responded to our first survey last summer. This is your opportunity to voice an opinion on a critical issue in San Rafael that will impact the Gerstle Park Neighborhood.

San Rafael to Revise City Noise Ordinance

The City of San Rafael is considering adoption of a revised noise ordinance to include decibel level standards, time periods within which noise can be made, categories of noise and exemptions from noise standards. Generally, the revised ordinance limits excessive noise to the hours of 7:00 a.m. to 10:00 p.m. Monday through Friday. Decibel level standards are set, and certain noise sources are either exempt or follow different hours. For example, refuse collection would be permitted in residential zones between 6:00 a.m. and 9:00 p.m. Certain exemptions from the provisions of the ordinance are designated, such as emergency vehicle sirens, noise sources from work on capital improvements by City employees, other public entities or City contractors. Call the San Rafael City Clerk's office (485-3066) for a copy of the proposed ordinance. A Report from Charlie Metcalf, SRPD Beat One Officer

Officer Metcalf wanted to let GPNA residents know about a series of daytime residential burglaries that have taken place in Terra Linda targeting notebook computers left in homes in the proximity of rear windows. Recently a similar burglary occurred also in the Sun Valley area. The suspect enters through an unlocked door at the rear of the house.

Officer Metcalf reminds us once again to keep all doors and windows locked. You can contact the San Rafael Police Department if you are not sure how secure your home is. There is somone available at the police department to do a home security check and recommend steps to make your home safer. Also, promptly report any suspicious behavior in your area to the Police Department. A call from a concerned neighbor could be just the break the police need to apprehend this burglar.

Gerstle Park's Tot Lot to be Updated

The City has determined that the Gerstle Park playground area for toddlers needs to be upgraded. Carlene McCart at the Park and Recrectreation Department indicates that it will be March or April of next year before anything can be done to the tot park, since the department is very busy now. Next spring we will walk the site with the engineers and do a preliminary plan. Once the plan is approved, they will hire an architect to design the area, looking at what kind of structures and play equipment we would like to see in the park. The process of planning will take several months, but we hope that construction will begin by early summer.

Did You Know??

Ever since our "dog leash" column, which sparked a bit of negative feedback, we've been procrastinating on this topic.
