



THIEVES IN GERSTLE PARK

While we enjoy our special neighborhood, unfortunately, we are not immune from crime, as a recent surge in auto break-ins shows us. Angelo Douvos, a Gerstle Park resident had the misfortune of experiencing this twice. He volunteered to write about his experience as well as provide tips on how to protect your car.

What do you do when, first thing in the morning, you go out to your car that's parked on the street in front of your house, only to find the front end panel, the tail light assembly, and the stereo gone? I know just what to do; I've been through it before. You go back inside the house, treat yourself for shock and exasperation with at least 15 minutes of meditation, call the police, and then call your insurance company.

My car was stolen last year from in front of my Clorinda Avenue house; it turned up in Richmond a few days later. Neighbors across the street from me had their car stolen not too long ago.

In August, my car was stripped while parked in front of my house and directly under a bright streetlight. I think the light helped the thieves see what they were doing. Also that night, my neighbor's car was broken into, a stereo was stolen from another car, and, as a garbage truck driver relates it, a nearby car was left on blocks with all four wheels gone.

Professional thieves look for easy marks and the auto parts they desire. My 1994 Acura provided \$2,000 of such parts. What can you do to protect your cars? First of all, neighbors watching the neighborhood are a powerful deterrent. Do not hesitate to call the police if you see suspicious activity. There are many preventative options available including alarms, steering wheel clubs, and the LoJack, which emits an inaudible signal that the police can track. Other ideas include a red blinking light for your dashboard; install a camera at the appropriate place; and an extreme option would be to build underground parking with a mean pit bull stationed inside your car and an ill-tempered armed guard nearby. VEGETATION MANAGEMENT: WHAT IS IT AND HOW DOES IT AFFECT ME?

With the recent fires in Southern California, it seems a good time to review our local vegetation management ordinance and what we can do to prevent a similar disaster from happening here. Most fires spread by flying sparks landing on flammable material. To minimize our fire risks, the City of San Rafael adopted the current ordinance in August of this year and it applies to any home that falls within what is called the Wildland-Urban Interface (WUI).

The ordinance's objective is to create a defensible space around each structure by reducing the fuel load, keeping the fire on the ground and slowing it down. This will give our fire and emergency personnel time to respond and to give your structure a fighting chance in the interim. The ordinance requires that very specific actions be taken if your property falls within the WUI. Every street in Gerstle Park is on the WUI list with the exception of:

San Rafael Ave Frances St Ivy Ln Taylor St

Elford St Treanor St Alvina Ave Marin St Welch St

There are some individual addresses also excluded from the WUI. To find out if your address is one of those, check the link at the bottom of this article.

The ordinance calls for 100 feet of defensible space around any structure. If your home is on the WUI list and there is only 30 feet from your home to your property line, it is the responsibility of the adjacent home/land owner to make sure that their property complies with the ordinance for the remainder of the distance (which in this case would be 70 feet).

While it is a good idea for every home regardless of location to have defensible space around it, if your home is on the WUI list, you are required by law to comply with the vegetation management ordinance. There is extensive information about vegetation management, defensible space and the ordinance itself on the City of San Rafael's web site and is also available as a handout at SRFD Station 1 (1039 C Street). Here are a few highlights of what defensible space means:

- ♦ Cut all dry grasses to 3" and then remove cuttings
- Remove combustible vegetation on the ground within 10 feet of any road used for vehicle traffic
- Remove dead wood from the ground that is less than 3" in diameter
- ♦ Maintain firewood away from structures so it is twice the distance away as the height of the pile
- Limb trees from the ground up to a maximum of 10' (but not more than 1/3 height of tree)
- ♦ Remove dead trees
- ♦ Cut back trees 10–15 feet from chimney remove all juniper and/or bamboo within 15 feet of your home (by 2011 you must remove it within 100'). Adjacent parcel owners must clear balance of footage from your property line to the 100' requirements.

The San Rafael Fire Department has created a three-year plan with a priority list for neighborhoods and Gerstle Park is slated for 2008. However, the ordinance is in effect now and they will be responding to any calls alerting them to particularly egregious properties. The fire department will come out and perform a free assessment of your property upon appointment (call 485-3488). When Gerstle Park rises to the top of the priority list sometime in 2008, the fire department will go door-to-door handing out packets of information and letters will be sent as well, informing the homeowners of their need to comply. Look for information in the IJ, on the city's web site and also from the GPNA.
